At Red and Orange:

- ✓ Visiting to be for one hour within the care home visiting hours and by appointment only.
- ✓ Two visitors per appointment if visiting in the resident's room, and four if visiting outside.
- ✓ Designated visiting areas per visitor vaccination status, with visits to occur outside whenever possible.
- ✓ Special exemptions will be granted under Red and Orange where the resident is critically ill or dying.

At all Traffic Light settings:

- ✓ All visitors to scan the QR code, sign into the Visitor Management System, have their temperature checked, provide evidence of their vaccination status, and be wearing a medical/surgical mask.
- No visitor will be allowed on site who is unwell/ symptomatic, under investigation of COVID-19 or is a close contact of someone who is under investigation for COVID-19 or a confirmed COVID-19 case.
